The certificate must include the Charlotte Area Chamber of Commerce as additional insured. The insurance limits should be a minimum of \$300,000 per occurrence for property damage and bodily injury. Exhibitors will be required to have proof of insurance before Move-In. NO EXCEPTIONS!


